



## Drivers 1st Medical

### Business Affiliate Agreement

#### PURPOSE

The purpose of this Agreement is to aid in the understanding of the relationship requirements between \_\_\_\_\_, hereafter referred to as “BUSINESS AFFILIATE” and Drivers 1<sup>st</sup> Medical LLC, hereafter referred to as “COMPANY” with regard to Business Affiliation.

#### REQUIREMENTS

##### Responsibilities of BUSINESS AFFILIATE

- BUSINESS AFFILIATE agrees to (check one):
  - Compensate company \$\_\_\_\_\_ for \_\_\_\_\_ driver(s) employed by BUSINESS AFFILIATE to receive DOT physical examinations.
  - Compensate company at a rate of \$\_\_\_\_\_ per driver to receive DOT physical examinations; OR refer all drivers employed by BUSINESS AFFILIATE to company to receive their DOT physical examinations. Drivers employed by BUSINESS AFFILIATE will receive a discounted rate of \$\_\_\_\_\_ per physical
- BUSINESS AFFILIATE agrees that drivers employed by BUSINESS AFFILIATE will only utilize company for DOT physicals during the period this agreement.
- BUSINESS AFFILIATE understands that DOT physicals will only include the following screenings: snellen vision exam, basic hearing screen, basic urinalysis, vital signs, and complete history and physical exam by certified medical examiner. If additional diagnostic or laboratory tests are required for driver certification, additional costs may apply. These costs will be the responsibility of the driver, driver’s health insurance, or BUSINESS AFFILIATE.

##### Responsibilities of COMPANY

- COMPANY will conduct DOT physicals for drivers employed by BUSINESS AFFILIATE at discounted rate listed above. DOT physicals will be conducted by a FMCSA certified medical examiner.
- COMPANY will maintain record of driver DOT physical examinations and provide copies to driver, BUSINESS AFFILIATE, or FMCSA upon request.
- COMPANY will provide referrals for drivers employed by BUSINESS AFFILIATE who require additional laboratory and/or diagnostic tests which cannot be performed by COMPANY.
- COMPANY will offer drivers employed by BUSINESS AFFILIATE priority scheduling for any diagnostic tests required for driver certification and offered by COMPANY. Diagnostics offered by COMPANY include Pulmonary Function tests, Chest X-Rays, EKGs, in-house Nocturnal Polysomnograms (Sleep Studies) and Home Sleep Studies. Additional costs for these services will be the responsibility of the driver, driver’s health insurance, or BUSINESS AFFILIATE. In the event that the driver’s health insurance will not cover these services, COMPANY will offer payment arrangements with driver or BUSINESS AFFILIATE at the discretion of the COMPANY.
